



YUMA PIPELINE



Overview

The Yuma Pipeline Project is a proposed natural gas infrastructure initiative designed to enhance energy supply for power generation, industrial operations, and residential use in northwestern Mexico and southwestern Arizona. Led by LED Enterprises, LLC—an affiliate of Grupo CLISA—the project aims to strengthen regional energy reliability and foster cross-border energy cooperation.

Project Specifications

The pipeline will span approximately 90 miles and feature a 30-inch diameter, with the capacity to transport up to 800 million cubic feet per day (MMcfd) of natural gas. Its route begins at an interconnection with El Paso Natural Gas Company, located about 7 miles southeast of Quartzsite, Arizona. From there, it will run southward and then westward, passing near Yuma, Arizona, before crossing the U.S.-Mexico border near San Luis, Arizona.

Purpose and Benefits

The project is intended to meet the rising demand for natural gas in northwestern Mexico and southwestern Arizona, supporting power generation and industrial development. By improving energy access, the pipeline is expected to promote economic growth in the surrounding regions and enhance long-term energy infrastructure.

Regulatory Process

On March 19, 2025, LED Enterprises began the pre-filing review process with the Federal Energy Regulatory Commission (FERC) under Docket Number PF25-8-000. This early-stage review is designed to facilitate collaboration with stakeholders and proactively address environmental and regulatory considerations. FERC accepted the pre-filing request on April 2, 2025, and will conduct formal public scoping meetings as part of the review process.



Public Engagement

To encourage community input, an informational open house meeting will be held in June and July 2025 for the public and elected officials. These events will provide an opportunity to learn more about the project, engage directly with the project team, and offer feedback ahead of the formal FERC application.
